

## END USER LICENSE AGREEMENT

This End User License Agreement (hereinafter referred to as EULA) is between Bosnien Business Systems d.o.o. (hereinafter referred to as BBS) and the company or person (hereinafter referred to as USER) who subscribes to the BBS' solution(s).

### THE USER ACCEPTS THE FOLLOWING CONDITIONS

#### Article 1.

##### Definitions

EULA is this End User License Agreement.

Agreement is End User License Agreement.

BBS is the company Bosnien Business Systems d.o.o. (Sarajevo, Bosnia and Herzegovina) that is the manufacturer and the owner of the intellectual property for BBS' solutions(s).

USER is the company or person who subscribes to the BBS' solution(s)

BBS' solution(s) are software solutions owned by BBS and available for the USER to subscribe to.

#### Article 2.

##### User Rights

This EULA gives the USER the right to access and use the BBS' solution(s) that the USER is subscribed to. The license granted hereunder is personal to the USER. BBS' solution(s) are licensed, not sold, to the USER for use only under the terms of this EULA. The license is non-exclusive and non-transferable. The USER has no rights to transfer any of the licenses, duties or obligations hereunder shall terminate this Agreement and be void. The USER has no rights to perform reverse engineering, decompile, or otherwise attempt to access the source code of BBS' solution(s).

#### Article 3.

##### User Obligations

The USER must subscribe to BBS' solution(s) service each month and pay to BBS according to BBS' price list. Renewal of monthly subscription will be automatic until User communicates in writing the desire to terminate the subscription. BBS grants the right to access and use the BBS' solution(s) that the USER is subscribed to only if the USER accepts all the terms of this agreement and pays the subscription price to BBS.

#### Article 4.

##### User Privacy

BBS will use personal data of the USER for logging and security purposes. The USER hereby states to grant BBS rights to process these data for the purpose as described here. If the USER confirms in written that BBS can use USER company information for its reference, BBS has its right to make that information public, on its website or other media. User Privacy is defined by Privacy Policy that must be available to the USER.

## Article 5.

### BBS Intellectual Property Rights

The BBS' solution(s) are the property of the BBS. The BBS' solution(s) are subject to applicable patent, copyright, trade secrets, trademarks, and other intellectual proprietary rights.

## Article 6.

### Warranties

The BBS' solution(s) are provided on an 'as is' basis. The BBS disclaims all warranties for the BBS' solution(s). Although the BBS' solution(s) are developed in a great professional manner, the BBS does not guaranty that BBS' solution(s) are error-free, or that the BBS' solution(s) will meet any specific functional requirement. The BBS makes no warranty that the BBS' solution(s) will meet any legal or regulatory requirements for local or global market. BBS accepts no responsibility for monitoring of legal requirements and regulations on local market. BBS will maintain the BBS' solution(s) in a great professional manner. The USER shall not be entitled to a refund of any fees or a payment of damages, it shall not affect its right to claim damages.

## Article 7.

### Dispute Resolving

The BBS and the USER agree that they will try to solve any possible dispute arising from this Agreement on principle of mutual understanding and consultations. Any dispute arising out of or relating to this Agreement that cannot be resolved by good faith negotiations shall be subject to the jurisdiction of the court in Sarajevo, Bosnia and Herzegovina.

## Article 8.

### Agreement Effect and Termination

The BBS or the USER can terminate this agreement at any time by notifying the other side in writing, prior to the 1st of the month (payment processing). The USER can terminate this agreement by Unsubscribe option for BBS' solution(s). This Agreement will terminate immediately if the User breaches one or more of its obligations outlined in this Agreement. The BBS has the right to terminate the Agreement with immediate effect, if the USER breaches one or more of its obligations outlined in this License Agreement. The BBS reserves the right, at its sole discretion, to change this Agreement, in whole or in part, at any time. This Agreement and license granted herein will terminate at the end of the last day of the month subscribed and for which payment has been received. This Agreement enters into force from the moment that the USER has accepted it.

BY CLICKING THE "I AGREE" OPTION, THE USER ACKNOWLEDGES THAT THE USER HAS READ THIS AGREEMENT, UNDERSTANDS IT, AND ACCEPTS ALL THE EULA TERMS. IF THE USER DOES NOT AGREE TO ALL TERMS IN THIS AGREEMENT, THE USER SHOULD NOT ACCESS OR USE BBS' SOLUTION(S).
